



WE STAND TOGETHER! SCHOOL-TO-SCHOOL SOLIDARITY CAMPAIGN

The We Stand Together! School-to-School Solidarity Campaign will match Montessori schools abroad with Montessori schools in Ukraine. Its central goal is to assist the Ukrainian Montessori community and schools with the financial and moral support they desperately need to stay open during the winter months and to survive the war. This is an emergency appeal; temperatures are dropping, the country's infrastructure is actively being destroyed, and the hardships faced by the Ukrainian people—especially its children—are mounting daily.

We seek to connect schools in Ukraine with schools abroad that share the belief that:

- Montessori education is an essential component to a peaceful future in Ukraine
- Children are natural agents of peace
- Partnerships for peace in Ukraine are mutually beneficial and enriching. By sharing information, resources and support, the entire Montessori community is strengthened.

To be eligible to participate in the We Stand Together! School-to-School Solidarity Campaign, Montessori schools in Ukraine must provide proof of meeting the following four (4) conditions:

1. At least one person on your team has received a Montessori credential or diploma.
2. Your school includes mixed-age group classrooms.
3. A Montessori environment planned to support independence according to age group is present in your school.
4. You commit to meet the reporting and accountability guidelines of MUU and your international partner school.

International partner schools who wish to support a Montessori school in Ukraine must meet the following four (4) conditions:

1. At least one person on your team has received a Montessori credential or diploma.
2. Your school includes mixed-age group classrooms.
3. A Montessori environment using Montessori materials and planned to support independence according to age group is present in your school.
4. You must detail what sort of reporting and/or accountability mechanisms your school requires to participate in this partnership. Kindly keep in mind that the people of Ukraine are living in a country at war and often in unsafe conditions, so reporting mechanisms should consist only of what support is necessary to verify that funds are being used for their intended purpose.

MUU is currently prioritizing partnerships that:

1. Can be swiftly implemented. Winter is coming and Montessori schools in Ukraine must stay open to continue to support the well-being and learning of children during the cold months ahead.
2. Support the replacement of materials that have been damaged, lost or looted during the conflict
3. Enable teachers to continue to facilitate an environment that supports the well-being of children and their families through training and other means (this could include direct support and coaching to teachers, peer-to-peer linkages, and training)
4. Facilitate the delivery of Montessori materials starter kits and other priority needs to those schools functioning underground, in basements and shelters for internally displaced people
5. Result in the translation of Montessori books and materials into the Ukrainian language.

MUU will not fund any activity or expenditure that violates MUU's tax-exempt status.

How to participate in We Stand Together! School-to-School Solidarity Campaign

Because the Montessori community in Ukraine needs emergency support, the MUU will review partnership applications daily. Our aim is to review and confirm school partnerships within 3 business days after all required documentation has been received.
